#### **Continuity of Educational Services**

- **Face-to-Face Instruction and Remote /Virtual Learning**

Haskell CISD does not plan to offer the option for remote/virtual learning. All students will be required to attend school Face-to-Face and attend school according to compulsory attendance laws.

- **Transportation Procedures**

Transportation services will be available during the 2021-2022 school year. HCISD buses will return to full occupancy and ridership. Buses will be cleaned regularly.

#### **Health Planning Guidance**

- **Prevention**

Haskell CISD must exclude students from attending school in person who are actively sick with COVID-19 or who have received a positive test result for COVID-19. Parents must ensure they do not send a child to a school campus or place them on a form of school transportation such as a school bus if the child

has COVID-19 symptoms or is test-confirmed with COVID-19. Student may return when the conditions for re-entry are met.

Teachers and staff must report to the school system if they themselves have COVID-19 symptoms or are lab confirmed with COVID-19, and if so, they must remain off campus until they meet the criteria for re-entry. Additionally, they must report to the school system if they have had close contact with an individual who is lab-confirmed with COVID-19.

### **Maintaining Health and Safety**

Haskell CISD has taken and will continue to take actions to ensure the health and safety of students, educators and staff. Haskell CISD will follow TEA Guidance <https://tea.texas.gov/sites/default/files/covid/SY-20-21-Public-Health-Guidance.pdf>

HCISD will maintain health and safety by the following practices:

- Hand sanitizing stations located at campus facilities
- Social distancing is encouraged, where applicable, but not required
- All employees will be trained to specifically follow health safety protocols
- Clean and disinfect each building regularly, with special attention to frequently touched surfaces
- Ensure that adequate cleaning supplies are available for staff use
- Staff will monitor the classrooms, hallways, playground and cafeteria to promote proper hygiene, handwashing and respiratory etiquette
- Masks are optional for any student or staff member. Per Executive Order GA-38, school systems cannot require students or staff to wear a mask
- Athletics and extracurricular activities will be conducted in alignment with UIL guidelines
- Visitor access will be limited on campuses this year, they are encouraged to call ahead and make an appointment if a meeting is necessary

### **Student Academic Needs**

Haskell CISD's system for tracking academic progress to inform instruction and provide regular feedback to parents and students regarding their progress will include:

- Three-week progress reports
- Formative assessments
- Diagnostic assessments
- Before and after school tutorials are provided for all students as needed

### **Student and Staff Social, Emotional and Mental Health Needs**

Haskell CISD is increasing the availability of counseling services.
