WHEREAS, the Board of Trustees of the Haskell Consolidated Independent School District ("District") have determined that the real properties and improvements located at 206 S Avenue E, Haskell, Texas 79521 are not necessary to meet the current and foreseeable needs of the District for educational purposes:

WHEREAS, the Board of Trustees has determined that the Properties should be advertised for sale or exchange pursuant to Chapter 272 of the Texas Local Government Code;

WHEREAS, the Board of Trustees has determined that the Properties should be sold subject to approval by the Board of Trustees of an offer;

WHEREAS, the Board of Trustees has determined that the services of a Real Estate Agent will substantially increase the sale value of the property;

NOW, THEREFORE BE IT RESOLVED, THAT:

- 1. The findings and recitals in the preamble of this Resolution are hereby found to be true and correct and are hereby approved and adopted;
- 2. The Board of Trustees authorizes the Superintendent of Schools, or his designee, to
 - a. survey the properties as necessary;
 - b. publish notice to the general public of the proposed sale in accordance with Chapter 272 of the Texas Local Government Code;
 - c. enter into an agreement with a real estate agent to market the property;
 - d. set the minimum proposal amount;
 - e. prepare a bid package with a real estate sales contract to provide to bidders;
 - f. receive and open proposals;
 - g. republish the notice required and extend the date of proposal opening as long as required to receive a proposal meeting or exceeding the minimum proposal amount;
 - h. present the bids with recommendation on a proposed purchaser of the properties to the Board of Trustees for approval of the sale.
- 3. The Board of Trustees is not obligated to accept any offer or to complete a sale; and
- 4. It is hereby found, determined and declared that sufficient written notice of the date, time, place and subject of the meeting of the Board of Trustees of the Haskell Consolidated Independent School District at which this Resolution was adopted was posted at a place convenient and readily accessible at all times to the general public for the time required by law preceding this meeting, as required by Chapter 551, Texas Government Code, and that this meeting has been open to the public as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon. The Board of Trustees further ratifies, approves and confirms such written notice and posting thereof.
